

## **T o u r   C o n d i t i o n**

### **1. Significance of this Tour Condition**

This outline tour conditions represents part of the term of transaction stipulated Article 12-4 of the Travel Agency Law, and the contract specifying services rendered for travel and other matters as stated in Article 12-5 of the law.

### **2. Contract for Agent-Organized Tours**

This travel is arranged by Toyama Chihou Railways(1-1-1 Sakura-machi, Toyama-shi, Toyama. [Licensed Travel Agency No.2-164 by the Toyama prefectural governor], here in after referred to as “Toyama Chihou Railways” )and client joining tours shall conclude an Agent-Organized Tour Contract(here in after referred to as the Travel Contract) with Toyama Chihou Railways.

### **3. Booking of the travel, and Effective Date of the Travel Contract**

(1)The Travel Contract becomes valid when Toyama Chihou Railways agrees to sign the contract and received the deposit from the client.

(2)Regardless of the provisions stipulated in (1)above, the contract becomes effective even without deposit.

A Travel Contract is put into effect then Toyama Chihou Railways agrees to reservations over the phone. (without any direct contact with the client) In the case of booking by postal mail, facsimile, or other such means, the contract is put into effect when Toyama Chihou Railways sends to the client a notification stating that Toyama Chihou Railways accepts the Travel Contract. Nevertheless, when the said notification is sent by means of electronic notifications of acceptance, such as e-mail, facsimile, the contract is put into effect when the electronic notification is delivered to the client.

### **4. Conditions for Booking**

A client under 20 years of age and traveling alone during the tour period shall provide Toyama Chihou Railways with written consent of his/her guardian. Clients under 15 years of age must be accompanied by a parent or guardian, except for certain courses.

## 5. Payment of the travel Fares

The tour fare shall be paid on the application date or date specified by Toyama Chihou Railways before the departure time.

## 6. Costs included in the Tour Fare

Fares for specified transportation fee, sales tax, other taxes. (Costs are not included in the course fees and personal expenses are not included)

## 7. Changing and Cancellation fee

Date of cancellation/Changing	
(1) 10-8 days before your tour	20% of tour rate
(2) 7-2 days before your tour	30% of tour rate
(3) 1 day before your tour	40% of tour rate
(4) Same day of your tour (Except #5)	50% of tour rate
(5) After the tour starts or No Show	100% of tour rate
